## Colorado Governor Taps JM to Save Energy

The Governor's Energy Office (GEO) and Johns Manville have teamed up to do an energy retro-fit on GEO's offices as part of Colorado Governor Bill Ritter's "Greening Government" plan, which seeks a 20-percent reduction in state government energy use by June 30, 2012. The added insulation will maximize GEO's energy efficiency, improve overall environmental performance and reduce operating costs. In addition, the project will serve as a model for energy efficiency in commercial buildings across Colorado.

JM donated Formaldehyde-free<sup>™</sup> fiber glass building insulation, including JM Spider<sup>™</sup> spray-in insulation and ComfortTherm<sup>®</sup> batts, for the project. The JM building science team provided technical expertise to ensure proper product selection and installation. Allied Insulation of Denver was the installer.

According to the U.S. Department of Energy, office building energy bills are the highest of any commercial building type. "A well-insulated building is essential to reducing the amount of energy needed to heat buildings in the winter and cool them in the summer," said Mike Fay, innovation leader. "By making buildings more energy efficient, we're also making them more comfortable for workers."

"GEO is committed to incorporating energy efficiency measures in built environments," said Tom Plant, GEO's director. "Our new energy-efficient office space will demonstrate how easy it is for building owners and managers to take these steps and experience an immediate return on their investment."

Colorado has more than 500 active real estate leases, 149 of which will expire in the next 12 months. The GEO's Greening Government program will create guidelines for the State's leased space to achieve its sustainability goals.
