#### **NRLN Writes Bush**

The following is a July 25, 2004 letter from National Retiree Legislative Network president Jim Norby to President Bush concerning retiree medical and pension benefits.

Dear Mr. President:

... we are a relatively large, diversified, and dedicated group of retirees and pre-retirees. As such, we have made ourselves privy to, and become active in, the political process. A quick review of our Web site will inform you and the staff of who we are and what we do. (www.NRLN.org)

We must inform you of the following facts:

Older American retirees are not going to stand aside and let their former employers take what they have earned away from them now that they are in retirement. – We're talking millions of retirees, Mr. President.

They are madder than hell and are resolved to do something about it.

If you haven't been told, let us do so now – there are thousands and thousands of Republicans switching their party affiliation. May we suggest the staff take a close look at Florida in that regard? As we recall, that was a very, very close win for you in the last election.

The most recent polls have the election at nearly dead even. Without some action on your part to address the issues of retirees, you are going to lose a large number of voters that you, at one time, had safely in your camp. They feel that you have betrayed them, and we believe they are going to let you know their feelings in the polling place. It is very late. It is critical that you get on with it.

What do we suggest?

Sign the following pledge:

"I, George W. Bush, if reelected President of the United States, will support measures that will ensure that pension and retiree health insurance promises will be honored. I further pledge that I will support other measures that will provide retirement security for present and future retirees."

Send a clear message that you will undertake the task of overhauling the recently passed Medicare Prescription Drug Act. We can, and will, assist in that task.

Place language in your party's Convention Platform that supports the position outlined in the pledge.

Thank you, Mr. President. We look forward to hearing from you soon.

# Join NRLN Jack Woodall

The Johns Manville Retiree Association is a member of the National Retiree Legislative Network and is looking for JM retirees interested in becoming involved in the activities of this organization. The NRLN represents nearly 2 million retirees from US West, BellTel, Prudential, Raytheon, Monsanto, IBM and many more.

The NRLN seeks to secure federal legislation that will guarantee the fair and equitable treatment of retirees in private and public sector health and pension programs and which will improve the adequacy of benefits provided by such programs. NRLN is committed to

securing fair treatment for all retirees, regardless of the type of benefit program involved.

NRLN is setting up a grass roots program across the country, with a leader in each state who will be responsible for the advocacy of retiree issues with congressional candidates, incumbents, and the press. This is the heart and soul of NRLN - a grass roots advocacy network.

The JM Retirees Association has been assigned the states of CA, IN, LA and MS to locate JM retirees who are willing to serve as state leaders to promote the goals of the NRLN. So far, we have located two leaders from CA and one leader for IN. These leaders are: John Turbeville - Southern CA, Howard Harvey - Northern CA, and Richard Pierce for the IN.

Although several retirees in MS and LA have been contacted, no one has agreed to serve as a state leader for these states. If anyone is interested in serving as a state leader in MS and LA, they should contact Burt Emery at abemory@iopener.net, or Jack Woodall at iwoodall@du.edu. The NRLN will provide a booklet outlining the responsibilities of a state leader and the objectives of the NRLN to anyone agreeing to serve. Additional information on current objectives will be provided on a regular basis.

And if you live in a state other than the above, also let Burt or Jack know if you are willing to serve. and they will pass your name on to the NRLN leader in that state.

#### **HMOs to Reap Huge Profits**

plans will receive
"significant benefits" as a result of
government payments to
participating plans provided by the
2003 Medicare law. Draft
regulations estimate that between
2004 and 2009 the law will pay
Medicare HMOs \$23.4 billion more
than what they would receive
without the law. Medicare
beneficiaries are not expected to
fare nearly as well.

During the same period, the Centers for Medicare and Medicaid Services projects that the benefits beyond traditional Medicare for beneficiaries enrolling in MA plans will be valued at only \$1.4 billion.

"This is proving once again that the Medicare law favors HMOs and pharmaceutical companies at the expense of Medicare beneficiaries," said George Kourpias, president of the Alliance for Retired Americans.

"HMOs will get \$23.4 billion from the federal government while beneficiaries will get only \$1.4 billion in benefits. This kind of wacky distribution of resources has to end. Seniors are going to strike back against this outrage when they vote in November."

Under the new Medicare law, Medicare Advantage plans, formerly known as Medicare+Choice, are managed care plans that will offer Medicare beneficiaries all Medicare-covered benefits including drugs and can provide additional benefits. They will receive substantial subsidies to compete with traditional Medicare.

## President's Corner John Leasher

Trecently came across the following Benjamin Franklin quotation: "Make yourselves sheep and the wolves will eat you."

Have we retirees made ourselves into sheep? Certainly the wolves seem to be out to eat us.

Almost every day we read about yet another company cutting retiree health benefits, increasing retirees' health premiums and co-pays, cutting out retiree health benefits altogether, unloading pension obligations onto the already under-funded federal agency that insures our pensions, and more.

And what is our government's response to these actions? More breaks for corporations. For example, the recently-modified Medicare Law gives subsidies and tax credits to employers even if they reduce or eliminate prescription drug benefits. Another example is the recent legislation that gave companies temporary pension funding relief through more liberal formulas, saving employers billions of dollars in payments.

While I could cite numerous other examples of retirees being harmed and corporations being helped, I think you get the picture.

So what should you do about this?

- · Get passionate.
- Say, "I'm mad as hell and I'm not going to take it anymore."
- Join NRLN—see Jack Woodall's article.
- Volunteer for the national grassroots legislative committee (see Jack Woodall's article in this issue).

- Call, write and visit your legislator to get his or her attention. Point out that the power of the senior vote should not be underestimated. (In 2000, 72% of registered seniors ages 65 to 72 voted, and this same group accounted for 25% of all the votes cast for president that year. Compare this with the fact that only 36% of registered voters ages 18 to 34 voted!)
- Write to your local newspapers and tell them what you think about what's happening to the 45 million current and future retirees in this country.

Or, be a sheep and let the wolves devour you.
