List," so I went to Warren Buffet's Berkshire Hathaway Annual Meeting in Omaha Last month. I loved hearing Warren and Charlie Munger speak in front of 40,000 people in the CenturyLink Arena. Warren said the way to tell Charlie (93 years old) and Warren (86) apart was that Charlie can hear and Warren can see. That certainly aligns with the JMRA. Charlie then said, "The only reason I'm here is so you know Warren's got at least seven more years."

They both then proceeded to answer questions from journalists and stockholders for six hours. It was very enlightening and there weren't any easy questions—"Why did you sell IBM?"—along with a discussion on integrity issues with Wells Fargo's misaligned marketing program for new accounts.

Speaking of difficult questions, we met with Mary Rhinehart, CEO of Johns Manville last December. We wanted to understand JM's position on a Cost of Living Allowance (COLA) for our Pension and/or a possible increase in our Health Reimbursement Account (a.k.a. Your Spending Account).

It was heartening to hear that People, which includes retirees, come first in JM's Core Values. Another Core Value, of course, is to Perform—this is the part that supports our pension. It is not easy being in an extremely cost competitive industry. Also JM is still recovering from serious price erosion during the great recession that started almost 10 years ago.

On the positive, JM has been paying more than the required minimum funding of our Pension even while the Plan Liability is decreasing (See the JM Annual Funding Notice for 2016). JM has closed the pension plan to all new hires and frozen the pension benefit for salaried employees as of 12-31-2007 which reduces volatility. JM still has to provide for increasing life expectancies of the pension participants.

Next, concerning the HRA/YSA, Johns Manville does monitor the Medicare supplement and Medicare Advantage plans for cost increases. With significant increases, JM might consider increasing the contribution amount for retirees. However, JM retirees with Medicare can have a lot of impact controlling their own cost by diligently picking their Part D/Prescription plan or Medicare Advantage plan provider during open enrollment **each year**. Don't assume last year's plan is the least expensive plan for next year. Put in your time at www.medicare.gov to get the lowest cost provider for your specific medications, or call 1-800-Medicare for help.

Lastly, JM and the JMRA will be following closely any changes passed by Congress concerning the Affordable Care Act (Obamacare) which would affect the JM retirees. We, and the JM people before us, are who made JM what it is today—we are the Veterans. You don't forget your Veterans. It may not happen this year or next year, but when the time is right we might see an increase in reimbursement benefits.

I hope this is helpful, especially to those who have written us this year. I also want to thank those who have sent in nice notes in support of what we do and just to say "Hello, Life is good!"

Any JM retiree who has been diagnosed with mesothelioma or other asbestos-related disease and believes it is a result of their employment at JM can direct questions to Mary Ann Loonam, a workers' compensation claims administrator at Johns Manville. Please note: Please do not contact JM if you only suspect you may have asbestos-related disease, but only after you have been to a doctor and have been diagnosed as having an asbestos-related disease.
