Tour of JM Tech Center

rior to our March Board of Directors meeting, we were treated to a tour of the renovations being made to JMTC. Rick Packard (Platform Leader of Facilities) was our tour guide.

The majority of the tour was focused on PD West, while work on the administration building and lab building remains. The exterior of the entire facility was retrofitted with some 1400 energy efficient windows.



If you remember the original PD West, it was virtually a series of deep dark caves. PD West was totally remodeled into an open airy facility with cubicles, offices, meeting rooms, conference rooms and eating areas.







PD West is now totally wireless for phone and laptops, but cell phone enhancers had to be added because the energy efficient windows blocked cell phone reception. All work stations have variable height desks to allow the people to sit or stand while working.

The fitness center has been relocated and expanded to three to four times the size of the original fitness center. The center is located on the "Blue Mile," the corridor leading to PD West. The room has one way windows so passers-by cannot see the people exercising.

Bottom line is that the facility is beautiful, bright and has wonderful JM graphics throughout the facility.
